At Sports Glamour Ltd, we take the privacy and protection of personal information seriously. This General Data Protection Regulation (GDPR) statement outlines how we collect, use, store, and disclose personal information on our website, <u>www.sportsglamour.co.uk</u>. transfers comply with applicable data protection laws and that appropriate safeguards are in place to protect personal information.
